Position of the course

The aim of the course unit 'Spanish Literatures (S3LI)' is for students to become acquainted with a range of important authors and literary movements from the 20th century until

nowadays (both Spanish and Latin-American texts). The unit provides the students with a general overview that should allow them to grasp references to literary milestones, to interpret important literary works, and to gauge their value. The course is available to exchange students.

Contents

The course unit 'Spanish Literature (S3LI)' focuses on a selection of important authors and literary movements of Spanish language literature of the 20th and 21st centuries. The students will furthermore become acquainted with a selection of literary analytical concepts, which will allow them to analyse, interpret and assess literary text excerpts. Special attention will also be paid to the context of the works.

Initial competences

The final objectives of the different Spanish units of study of the second bachelor year.

Final competences

- 1 Having a command of Spanish at C1 level of the Common European Framework of Reference for Languages for comprehension (listening and reading), in particular for the comprehension of literary text and specialised texts on translation theory [B.1.2, assessed]
- 2 Recognising language structures and language variation of Spanish, in particular characteristics determined by literary conventions, authors' idiosyncrasies and geographical variations (especially Peninsular, Mexican, and Rioplatense Spanish) [B.1.3, assessed]
- 3 Having knowledge and understanding of the cultural and institutional context of the Spanish language area and use that knowledge for the interpretation of written texts, in particular literary texts [B.1.5, assessed]
- 4 Having basic knowledge and understanding of supporting sciences (e.g. stylistics and narratology) and applying it to the interpretation of literary texts [B.1.8, not assessed]
- 5 Having knowledge of the main contemporary literary currents and authors of the Spanishspeaking world.

Extra information on the examination methods

The course unit is assessed by means of an oral end-of-term examination, and during the semester the student also has to complete weekly preparatory assignments (question-driven readings of literary texts). The students are expected to participate actively in the text discussions. The oral exam consists of three parts. Part 1 assesses the student's knowledge about one or more authors, movements or periods. Part 2 requires the student to interpret and situate an excerpt commented in class. The excerpt is not anonymous: the author is named. Part 3 requires the student to discuss the individually read novel(s) (reading at home).

Calculation of the examination mark

The oral exam consists of three parts. Part 1 accounts for 5 points (25%). Part 2 accounts for 10 points (50%). Part 3 accounts for 5 points (25%).

Facilities for Working Students

Student attendance during educational activities is not required: alternative assignments are possible. The students have to contact the lecturer-in-charge at the start of the semester.
