Position of the course

Accessing knowledge of Swedish literary history, from the 18th century onwards, focusing on the most important literary movements and periods and on important institutional developments.

Contents

Swedish Literature II deals with Swedish literary history from the 18th century to the present day. Introductory consideration is given to literary historiography as such and to the most important literature historical overview works dealing with Swedish literature. Subsequently, the main literary historical developments are discussed from a double perspective. The course focuses on the development of the literary system and discusses the most important literary institutions and institutional roles from a historical perspective. In addition, attention is paid to the most important periods and movements in Swedish literature.

Initial competences

To have successfully completed the course Swedish literature I or to have acquired the necessary skills by other means.

- 1 Having insight into the principles of literary historiography, especially applied to Swedish literary historiography.
- 2 Having insight inot Swedish literary history
- 3 Having insight into the institutional determination of literature.
- 4 Being familiar with the main developments in Swedish literary history from the 18th century to the present day.
- 5 Being familiar with the main literary institutions and institutional roles and their

developments in the context of Swedish literature.

6 Participating in Swedish in an oral discussion on literary historical themes.

7 Reflect in good Swedish (ERK level: B2) insightfully, in a clear and coherent way, without using GAI tools in text production and/or editing, in writing on a question relevant in the context of the course.
