## Position of the course

This course is part of the programme of the Master of Science in Educational Sciences (main subject Pedagogy and Educational Sciences). The course is furthermore an optional course for students in the Master of Science in Social Work and Social Welfare Studies and students not enrolled in Educational Sciences (e.g. Sociology, Gender & Diversity). The course is taught in English, so also international students can register. Within this course, students focus on the educational and societal role of culture from an interdisciplinary and international perspective.

## Contents

This course consists of the following modules:

• Culture & Society: Introduction into the debate on the educational and societal 'value' of culture and the arts. What is currently considered to be valuable knowledge about culture? How is this knowledge being challenged and how is it redefined? What does this imply for education and for the curriculum in general?

- Culture & Identity: Introduction into theoretical frameworks and topical debates on culture and identity. How are educational and societal conflicts increasingly grounded in notions of identity and otherness?
- Culture & Research: How can we study identity politics and the politics of representation through culture and the arts? How can art be a form of education?

Through guest lecures and participation in cultural activities, these questions are further related to current discussions. Based on reflection and research assignments, the focus within this course is on the 'reflective/critical scientist practitioner'.

- 1 The student can analyze and evaluate the representation of educational and social problems in (cultural) narratives.
- 2 To student can perform an analysis of a cultural product independently.
- 3 The student can analyze educational and societal debates based on insights from rhetoric.
- 4 The student can engage in interdisciplinary group discussions in culture, identity and rhetoric.
- 5 The student can analyze and interpret the concept of culture in its broad sense and, particularly, situate it with respect for concepts like power, social exclusion and creativity.
- 6 The student can analyze and discuss in an investigating and personal manner a number of current problems and dilemmas in cultural policy and practice.
