- Planning and management systems of pharmaceutical R&D projects, production and stock (by Arie Moruanx).
- Environment, climate change and socio-economic aspects in pharmaceutical business.
- Pharmaceutical market forces, value creation and marketing (by Agnes Degroote).
- Aspects of intellectual property of health products (by Steven Cattoor).
