# Position of the course

This intermediate course in Swedish grammar is given during the fourth semester of the bachelor program.

# Contents

The course builds on the body of knowledge covered in the introductory course in Swedish linguistics. Traditional grammar remains the basis for analysis, but some of its limitations and shortcomings are discussed. The subject matter of grammatical analysis is extended from basic grammatical structures to also include specific grammatical phenomena, such as object shift, pseudocoordination and incongruent predicative. Emphasis is put on the application of analytical tools on grammatical phenomena and, to a smaller extent, on the assessment of different analyses of the same phenomenon. Electronic corpora are used in the course as a means to investigate grammatical questions, and the students learn methods for finding grammatical patterns in annotated corpora. The students apply their knowledge and ability in the writing of a scientific report, which is presented and discussed in a seminar.

#### Initial competences

To have completed the course *Swedish Linguistics: Introduction* or to have acquired equivalent skills and knowledge by other means.

#### Final competences

- 1 To have acquired intermediate theoretical knowledge of the grammatical structure of Swedish, including some specific phenomena that pose a challenge to grammatical accounts of Swedish.
- 2 To be able to discuss the reasons for or against adopting a grammatical analysis or solution
- 3 To be able to compare different grammatical analyses of the same structure.
- 4 To be able to conduct a linguistic study using material collected from a corpus.

- 5 To be able to present a linguistic study in written and oral form.
- 6 To have attained sufficient theoretical knowledge so as to be prepared to engage in the study of a specific grammatical framework.
