**Situering**

The course provides a specialization in the study of grammatical case from both a comparative and a typological perspective, as well as its place in theoretical approaches focused on the lexicon and syntax.

**Inhoud**

In this course we will investigate grammatical case, a hotly debated issue in descriptive and theoretical linguistics, by adopting a contrastive and typological perspective. What are the reasons why languages mark elements with case, and what are the attested ways in which different languages manifest case? Why, and how, do other languages present no grammatical case? We will pay attention to the manifestations of case and the proposed analyses in a wide typological and areal range of languages spanning from Europe and Asia to the Amazon and Australia. The overview of existing theoretical approaches will be complemented with different hypotheses on case assignment and its morphological patterns, and the corresponding syntactic structures. Several types of phenomena and analyses of grammatical case will be explored by means of case studies, such as alignment typology, hierarchy effects, differential case marking, or the diachrony of case systems. Each student will be asked to write a small comparative study, presented both orally and in a written paper, either by picking a language of their choice and analyzing the morphological and syntactic patterns of case marking in this language, or by focusing on a specific phenomenon related to case with a wider comparative approach.
