Poetry in Flanders (1945-2000)

#### Position of the course

The course discusses important trends in Flemish poetry between 1945 and 2000. Important poems by Flemish writers are analysed, interpreted and contextualized.

#### Contents

In part 1 of the course specific trends are discussed in the Flemish poetry landscape from 1945 till 2000. The lectures work with a comparative perspective (comparing poetry systems of Flanders and the Netherlands). In part 2 particular case studies are examined of canonised Flemish poets (e.g. Hugo Claus, Leonard Nolens, Willy Roggeman, Stefan Hertmans).

## Initial competences

The student is fully versed in the history of Dutch literature and in the most important poetical developments. He or she is acquainted with the principles of literary theory and criticism.

## Final competences

- 1 The student has acquired insight into the literary context of Dutch/Flemish poetry since the Second World War
- 2 The student can produce an in-depth analysis of literary texts.
- 3 The student can use literary theory to analyse literary texts
- 4 The student can report the acquired insights efficiently and correctly.
- 5 The student is able to draw theoretical conclusions from a literary analysis in a critical way.

The course alternates lectures with discussions. The student analyses a poem in an individual paper.

Choice of a poem or a series of poems from *Waar is de eerste morgen?* (ed. Jan Walravens), 1955. The anthology is accesible in pdf on Ufora.

This course assumes that students will practice responsible use of generative artificial intelligence (AI). What this means in practical terms will be explained during lectures.
