Handling sources critically, history

Position of the course

This general introductory course wants to provide insight into the subsequent stages of historical research: what is a source? How can one judge the authenticity of a source? How to handle contradicting sources concerning the same phenomenon? Finally, this course gives an overview of historical synthesis and historiography.

Contents

The course presents a method to deal critically with the flow of information which confronts the present day consumer of information, it also illustrates in which way a similar situation was at stake at different moments in the past. How to search for sources, how to deal critically with them, and above all: how to react if sources contradict each other? How to proceed from a confrontation of contradicting sources concerning the same phenomenon, to an almost certain interpretation, as close as possible to reality? In the process the motives which led to the line of reconstructed events receive as much attention. In a second part, the course focuses on the historical synthesis, the way in which past generations have constructed their past. The development of history as a autonomous science is also dealt with: in which way did ideology, politics and philosophy shape the image of the past? All theories are illustrated with practical examples. The course in itself has a honourable history and has now presents a methodological approach not only for obvious reasons of great importance to historians, but also to other fields of study among humanities and social sciences.

- To have a standard language knowledge (Dutch, French, English, German).

Written. The exam wants to evaluate different abilities: knowledge of theory (multiple choice questions concerning the handbook); capability to synthesize (open question concerning one of the cases dealt with in the course); insight (open question concerning an unknown text). Shortly before the last lesson, a try-out examination is organised, students therefore are confronted before the real examination with the kind of questions asked, on the faculty's website examples of questions are to be found.

Calculation of the examination mark

Half of the credits (10 out of 20) to be acquired via the multiple choice questions; second half via the 'open' questions (5 out of 20 for the question linked to the case; 5 out of 20 for the free question concerning an unseen text.
