Position of the course

This advanced course in Swedish grammar is given during the fourth semester of the bachelor program.

Contents

This course builds on the knowledge the students have attained during Swedish linguistics I. The grammatical analysis of Swedish will be extended to authentic written and oral texts. Traditional grammar constitutes the point-of-departure, but its limitations and shortcomings will be discussed. The overall language focus is on Swedish, but contrastive analysis is also part of the course. The students apply their knowledge and ability in the writing of a scientific report which will also be discussed in a seminar.

Initial competences

To have completed the course Swedish Linguistics I or to have acquired the necessary skills by other means.

Final competences

- 1 The students have acquired a deepened theoretical knowledge of the syntactic structure of Swedish and its variation in written and spoken language;
- 2 The student is able to reason about the validity of a grammatical analysis or solution, under the guidence of the teacher;
- 3 The student can conduct and present a smaller scientific study;
- 4 The student is able to critically review and value the tools within traditional grammar.

Teaching methods

Lecture, Seminar: coached exercises

The teaching methods mostly consist of lectures and teacher-guided exercises. In addition, there are 2-4 discussion seminars to which the students are expected to prepare a number of questions and/or exercises.
