History of Belgium in the context of the development of the Western World and with the internal cleavages of Belgian society as a starting point

**Position of the course**

This basic course teaches students how contemporary Belgian society is the historical outcome of economic, social and political developments.

**Contents**

In this course, Belgian history is taught chronologically and thematically starting from the traditional cleavages (socio-economic – religious/ideological - linguistic/regional). Students know the major social, political and institutional processes that are active in the socio-political history of Belgium since the end of the 18th century up to present and are able to place this within an international context. The interference of international developments (wars, colonization and decolonization, migration) in Belgian history are the occasion to elaborate on global history. The students are able to demonstrate how the three major fracture lines have determined Belgian history and how new fracture lines take shape from the 1960s on.

They are also able to apply this basic knowledge to current situations and debates via a case study on a specific topic from the Belgian past and the societal memory linked to it. Students process a 'historical dossier' regarding aspects of Belgian collective memory, connected to themes dealt with during the course. They also search and add other relevant materials to this dossier.

### **Initial competences**

To have reached the final attainment levels of the subject 'history' in Flemish secondary education (or a comparable level)

### **Final competences**

- 1 To have a frame of reference of Belgian history in an international perspective.
- 2 To be able to situate the main points of the social, political and institutional processes which have shaped the socio-political history of Belgium since the late 18th century in an international context.
- 3 To understand how the three main breaks (socio-economical, ideological, lingual-communal) have influenced Belgian history.
- 4 To have an insight into general developments within Belgian history.
- 5 To be able to link the knowledge of and insights into the history of Belgium to current events and trends.
- 6 Have advanced insight into the use of the historical terminological framework for analyzing and evaluating new and complex ideas.
- 7 Have insights into the history of the Low Countries and of Belgium in the international context.
- 8 To critically evaluate current social problems and ideas from a historical perspective.
- 9 Interpret current developments from a historical-comparative perspective.
- 10 To apply digital methods, tools and strategies during a research process (discover).
