#### Teaching languages

Literary history, historiography, theory, method

#### Position of the course

This advanced course provides an insight into the theory and the application of the historical study of literary texts and the problems of literary history.

#### Contents

In this course, students are made familiar with several basic concepts from the historical study of literary texts and the historiography of literature. Following questions are dealt with: What is the object of 'historical literature'? What are the (dis)advantages of a cultural-historical reading? Which shape can that kind of reading take? How can we define the concept 'context'? How are literary texts different from other historical sources? Students are thus briefly introduced into recent developed reading practices such as a.o. 'Cultural Materialism' and 'New Historicism'. Transnational literary history and developments within the 'digital turn' will be discussed as well.

At the same time, students are introduced into the methodology of historical research of literature. This part focuses on the material aspects of text carriers (especially manuscripts and early prints), and on the editing technique, insofar as this has implications for the textual history. This is all embedded in a history of the book. Concerning manuscript literature, the consequences of the perspectives of the New/Material Philology for the study of historical literature are examined. The object of this course is that the students are making a comparative analysis of how a literary work or an author is presented in different literary histories in the course of time. They will do this along the information given in the lectures, guided reading of secondary texts, and exercises.

- 1 To apply knowledge of the literary traditions to the analysis of texts and to the placing in a literary-historical and stylistic context.
- 2 To have an insight into the historical functions of literature.

- 5 To have an insight into the state of affairs of literary research.
- 6 To activate insight into the historical aspects in the study of texts.
- 7 To have an eye for the relations between languages, literatures and cultures.
- 8 To have an insight in related and supporting disciplines and to be able to indicate their importance for the literary research.
- 9 To contextualize sources and studies on literature and culture and to assimilate them critically.
- 10 To reproduce and apply literary paradigms, methods of analysis and techniques of interpretation.
- 11 To be aware of the historical and ideological determination of problems of research and of the necessity to question the research process.
- 12 To have a strong linguistic awareness: valueing the crucial role of language in human interaction and cultural production and handling language according to that awareness.
- 13 Showing an attitude of intellectual curiosity and lifelong learning.
- 14 To have an eye for social problems, and to be conscious of the use of the field.
- 15 To design independently a research question and to solve it in a scientifically

sound way, under supervision.
