### Teaching languages

#### Keywords

Deeper morphological knowledge, syntax, syntactical obligatory and non-obligatory extensions, simplex and complex sentences, metrical rules.

#### Position of the course

This introductory course wants to provide a deeper knowledge of latin morfphology and gives an insight into basic syntactical structures of sentence structure in Latin with focus on dependent clauses, direct and indirect discourse. There will be an introduction to metrical systems with the focus on the elegic distichon..

## Contents

Selected items of the Latin morphology, scientific background of the morphosyntax; syntax of the Latin clause: position and meaning of syntactical functions and extensions. thorough repetition and practice of the acquired knowledge of Latin: Taalbeheersing I will be repeated with exercises on morphology and syntax (reading of texts and making of translations)

#### Initial competences

To have followed the course Latin: Language Proficiency I or to have gotten acquainted with the necessary skills by other means.

#### Final competences

- 1 To recognize and explain the rules for the use and positioning of syntactical functions and extensions in the Latin sentence.
- 2 To analyse a complex Latin sentence syntactically.
- 3 To read and comprehend a Latin text.
- 4 To analyse a Latin sentence thoroughly on all levels.

- 5 To make a morphosyntactical analysis of words within a clause.
- 6 To get acquainted with the Latin language in order to be able to summarize or transpose given Latin texts and sentences and translate from Dutch into Latin.
- 7 Recognize and aply the rules of the dactylic hexameter and pentameter.
- 8 Understanding Latin colometry and being capable of recognizing and indicating the cola in the Latin sentence.
- 9 To master a selection of Latin texts on an independent base.

#### Teaching methods

Seminar, Lecture, Independent work

#### Extra information on the teaching methods

- Lecture (20%): a theoretical part
- Seminar on method of reading and analysis of Latin texts, consisting of a tutorial with supervised exercises (30%) and supervised self-teaching (20%).
- Independent reading of a text corpus by self-activation + independent analysis of one paragraph in the independent reading (30%).
- Keeping of a portfolio with autonomous work

#### Calculation of the examination mark

Oral exam: 45%

Written exam: 40%

Non-periodical evalutation: 15%

Knowledge of the content of the course Latin: Language Proficiency I is taken for granted.

Failures can lead to a negative result for the examination as a whole.

Unmotivated absence at the tests leads to the score of zero for that test. The final mark is the different components' weighted average. Students can only achieve a pass for this course unit if they have a minimum of 10/20 for the periodical evaluation (written and oral together). If the student scores less than 10/20 for the periodical evaluation, and the final mark turns out to be a 10/20 or more, this will be reduced to the highest non-pass mark, i.e. 9/20.
