Teaching languages

German, linguistics, syntaxis, language variation

Position of the course

Nobody speaks German the way it is written. But what are e.g. syntactic constructions that are typical of spoken German, and how can they be described formally and analysed structurally? This course zooms in on a number of **syntactic phenomena at the clausal left periphery** and looks at factors that influence the word order in the left periphery, or are influenced by it, such as informations structure and prosody, but also language contact and sociolinguistic factors.

Contents

After a short refreshing of existing knowledge about syntactic analysis (aquired in e.g. ATW and German Linguistics 2), we discuss a number of constructions and their possible analysis based on a number of linguistics articles (in German). The students read those articles independently for the sessio in which they will be covered, and send in 3-5 questions about the article in preparation of the class. On the basis of these, the sessions will partially be built dynamically around this input. One of the students leads the discussion. Next to that, the students work on a corpus of spoken German in order to research in which contexts the constructions discussed in the literature are found. They present the results of their research in an individual presentation.

The necessary techniques for academic writing will be rehearsed and advanced. There is a tutorial (7.5h) accompanying this course, where students are guided for their research task. The reading tasks contribute to 30% of the final grade, the presentation for 40% (these task together form a portfolio), and the oral exam for 30%.

Initial competences

Final competences

- 1 To have gained an insight into the hierarchical nature of clause structure.
- 2 To be able to analyse (non-standard) syntactic constructions in German within a formal syntactic framework.
- 3 Independent and critical processing of academic linguistics texts.
- 4 An independent and critical application of the theoretical tools also to new data.
