# **Teaching languages**

French

# Keywords

French historical linguistics, phonetics, phonology, morphology, lexicon, inherited words, language evolution

#### Position of the course

The purpose of this module (1 block per week) is to give an insight into the genesis of French from Latin. More specifically, we will study : 1. the lexical heritage from Latin (the share of Latin inherited words in the French lexicon) 2. sound evolutions and their traces in contemporary spelling 3. similarities with other Romance languages.

This course prepares students for a thorough study of Old French texts.

#### Contents

The first part of the course focuses on the genesis of French and on the origin of the French lexicon (inherited words, loanwords, derivations, etc.). Then follows a study of the evolution of the sounds in French and its impact on contemporary French spelling. Particular attention is paid to the main phenomena that underlie the phonetic developments (e.g. the role of the accent, palatalization, nasalization, diphthongization, etc.). The analyses will be illustrated with numerous examples and exercises, which focus not only on the phonetic evolution, but also on scientific argumentation.

# Initial competences

To have completed the French linguistics I and II course or to have mastered the intended competence in another way.

#### **Final competences**

- 1 Have insight into the historical connections between Latin and French
- 2 Explain the phonetic evolution of words and understand their impact on spelling
- 3 Differentiate between inherited words and loanwords
- 4 Interpret linguistic data, form hypotheses and build scientific argumentations
- 5 Master the specific terminology + to use the language grammatically correctly and in a stylistically accurate way

#### **Teaching methods**

Group work, Seminar, Independent work

#### Extra information on the teaching methods

During the contact hours, the learning material will be taught in an interactive way and applied to exercices. In addition, students are expected to study autonomously a part of the syllabus and to do some exercices in an independant way. During the classes references will be made to this material and there will be room to ask questions. Finally, the students also deepen one particular aspect of the course by means of a collective video presentation.

The classes take place on campus; if needed (e.g. due to Covid), occasional switching to online streaming may be envisaged.
