Position of the course

This basic course provides insight into pronunciation, phonology, basic syntactical structures of word and sentence structure in Latin (basic sentence with obligatory extensions: functionality of the cases), overview of subordinate clauses.

Preparatory Course Master of Arts in Linguistics and Literature(main subject Latin)

Contents

Introduction into the fundamentals of phonology and lexicology: word formation, derived verbal forms, nominal forms of the verb. Overview of the basis morphology and syntax. Syntactical patterns in sentence structure in Latin: nominal phrase, the verb and its complements; syntax

of the verb in the main clause, use of nominal verbforms. The contents of the course will be adapted to the beginning competences of the student.

Initial competences

Having acquired the basic competences of the "Algemeen Secundair Onderwijs". The course is open to student without basic knowlegde of Latin. At the beginning of the academic year an orientation test will take place in order to distribute the students in different groups. Students without basic knowledge of Latin are of course expected the do a lot of indipendent work.

Final competences

- 1 To master the pronunciation and accentuation of classical Latin.
- 2 To know and apply the most important phonological Latin rules.
- 3 To master the basis of Latin vocabulary.
- 4 To know and apply the morphology of classical Latin.
- 5 To have insight into structure of Latin clauses.
- 6 To have insight into the basic syntax of classical Latin (functions of the cases, syntax of singular sentences)
- 7 To make a morphosyntactical analysis of Latin words within a syntactical structure.
- 8 To recognize and explain syntactical functions.
- 9 To show the capacity of reflecting on the meaning of Latin words.
- 10 To integrate and apply the known grammar and vocabulary by means of the compositions of simple sentences.
- 11 To be able to understand Latin texts in order to make easyly a translation.

- Lecture (15 h): a theoretical introduction on pronunciation, phonolgy, morphology and syntax

- Conducted exercises (15 h) on pronunciation, phonology, morphology and syntax; Seminar on method of reading and analysis of Latin texts.

Periodical evaluation in the first period of examination: written examination with open questions on phonology, morphology and syntax.

Periodical evaluation in the secibd period of examination: written examination with open questions on phonology, morphology and syntax

Non-periodical evaluation: continuous assessments portfolio with extra exercises (Ufora), skill test

Second-chance examination in case of non-periodical evaluation: examination in the second period is not possible

Explanation of the evaluation forms: (a) Periodical: written examination with open questions (activ and passiv knowledge) on morphosyntax and phonology; the examination is directly linked to the final competences. (b) Non-periodical: permanent (tests on phonology, morphology, syntax)

Calculation of the examination mark

Periodical: written examination (70%)

Non-periodical: Permanent - tests (30%). (Participation in each part of the evaluation is compulsory).

Unmotivated absence at one of the tests leads to the score of zero for that test. The final mark is the different components' weighted average. Students can only achieve a pass for this course unit if they have a minimum of 10/20 for the periodical evaluation. If the student scores less than 10/20 for the periodical evaluation, and the final mark turns out to be a 10/20 or more, this will be reduced to the highest non-pass mark, i.e. 9/20.
