Position of the course

The course aims at the acquisition of knowledge and insight into the evolution of geographical mapmaking, the techniques, reliability, actuality, precision and filiation of historical cartographic material.

Contents

- History of geographical insights through times around the world.
- Historical criticism of ancient maps.
- Survey of historical cartography:
 - ° cartography before the scientific revolution of the 16th century.
 - ° local cartography and local surveys from the 13th century to the Napoleonic land registration.
 - ° maritime cartography.
 - ° chorographical mapping between the 16th and 18th century.
 - ° topographical cartography of lands from the 18 century onwards.
 - ° thematic cartography from the 19 century onwards.
- Evolution of orientation, map projections, and reproduction techniques in the last 250 years.
- Acquisition techniques.
- Visits to archives and museums.
