#### Position of the course

The course is given during the first semester of the master program in Scandinavian languages

## Contents

The content of this course alternates between specific case studies of linguistic phenomena in the Scandinavian languages. Each case is studied from as many angles as possible: syntax, semantics, pragmatics and the philosophy of language. The pros and cons of different scientfic methods to study linguistic phenomena are discussed, such as introspection, corpora studies, informant studies etc. Issues related to language acquisition, language change and language policy may also be discussed if relevant to the specific case. Though the main focus is on Swedish, the other Scandinavian languages are also discussed.

#### Initial competences

The student has a BA in Linguistics and Literature with Swedish as one of the studied languages.

#### Final competences

- 1 After completing the course, the student should:
  - have attained a better theoretical knowledge of the relevant case study;
- 2 be able to reason with some guidance from the teacher about linguistic problems and the validity of linguistic explanations;
- 3 be able to independently carry out a small corpora study of written or spoken Swedish;
- 4 be able to theoretically account for a linguistic phenomenon in a paper that adheres to the genre expectations of the scientific report;
- 5 be able to read and critically review scientific articles/chapters from linguistic journals and books.

## Extra information on the examination methods

The end-of-term evaluation consists of 1) an individually written scientific report on a topic that has been addressed during the course (50% of the examination mark), and 2) defending the report and acting as opponent of another student report at a defense seminar (10% of the examination mark).

The continuous assessment consists of

- 1) Active participation in a communal research project to be conducted in class and as homework (20 % of the examination mark).
- 2) Collaborative writing of a scientific report from this research project. (20% of the examination mark).

#### Calculation of the examination mark
