## Position of the course

- to obtain a profound insight into ideology critical and text-strategic processes in literary texts in German
- excellent mastery of the skills needed to perform textual analysis and interpretation of literary texts in German
- to be able to contribute to the scientific study of literary texts in German in a creative way
- excellent knowledge of German

Exchange students may take up this course unit, for which no prior knowledge of Dutch is required.

## Contents

This course discusses current methodologies in literary studies and their relation to classical literary-theoretical approaches. The topics are closely connected to the research done in the Research Unit German Literature. Older (18th century) or contemporary (postmodern) texts with a specific thematic, genological or historical dimension are analysed and interpreted, focusing on their ideological and text-strategic features. In this way, various topics (such as the representation of paedagogical projects in the 18th century, the concept of "Europe" in 20th century German literature or the postmodern pseudo-historical novel, etc.) are brought into focus. The analyses are embedded in a theoretical discussion about the current position and practice of Hermeneutics and Interpretation in literary theory. The

choices made with respect to theme, problem field and text, assure that a historical and chronological profile of German literature is offered.

The overarching topic of the seminar changes every year and will be definitively communicated to the students together with the reading list on Ufora at the beginning of the academic year. Previous topics include 'Selbsdarstellung in der Literatur' and 'Starke Frauen'.

For the academic year 2023-2024, the expected theme will be neurodiversity, as has been the case in previous years. The concept of neurodiversity can help to put established authors in a new light in German-language literary history. This approach leads to innovative text interpretations and makes it possible to critically reflect on past and current frameworks and analyses. Specific covered topics are literary depictions of hypo- and hypersensitivity, the link between trauma and neurodiversity, therapeutic writing...

## Extra information on the teaching methods

Seminar (22.5h): under the supervision of the lecturer(s) the students work acquaint themselves with an advanced research problem pertaining to the study of German literature; they discuss and evaluate research results.

Presentation (15h): students present their research findings about a text (presentation of 30 minutes)

Independent work (7,5h): the students perform the research activities necessary for the presentation.

No lesson recordings are provided. Attendance in classes is highly recommended.

Permanent evaluation (presentations, participation of the students) and an oral exam.

#### Calculation of the examination mark

Presentation: 30%

Essay: 30%

Participation: 10%

Oral exam: 30%

If the student did not pass the non-periodic evaluation, a second chance will be offered through a compensatory activity between the first and second exam period. Students who participate in the bonus programme, can earn an extra bonus mark. Those with a failing grade for either of the two end-of-term forms of assessment cannot pass the course as a whole. If the final score would nevertheless be a mark of 10 or more out of 20, this will be reduced to the highest unsuccessful mark (i.e. 9/20). If one does not participate in the evaluation of one or more components, one can no longer pass the course unit as a whole and the final grade, if higher than 7/20, will be reduced to the highest non-deliberable grade (i.e. 7/20). The extra bonus mark can only be awarded to students who pass the course as a whole.
