#### Position of the course

This advanced course assists students in conceiving, planning, researching, writing and revising a BA Paper ("onderzoekstaak") in the field of literature in English.

#### Contents

The course addresses research, writing and presentation skills and resources in the field of literature in English. Students will be required to complete several assignments for the seminar as preparation for their BA papers. Students are encouraged to reflect on the comments and advice received from the teachers, the student assigned to respond to their presentation, fellow students and/or other members of the audience for the Symposium, and to revise their BA paper in accordance with any new insights they may have gained before the BA paper

submission deadline. Students will receive a detailed calendar of the planned activities at the start of the course.

#### Initial competences

- To have successfully completed the standard course Ba2 or to have acquired the necessary skills by other means.
- To have advanced knowledge of the characteristics of English literary texts and the historical functioning of literature in English
- To have as yet limited experience of independent research into scholarly problems.

#### Final competences

- 1 To gain insight into the specific demands of academic research into aspects of literature in English
- 2 To be able to research a (small-scale) problem
- 3 To be able to report research results, both orally and in writing
- 4 To be able to critically assess the research results of others
- 5 To able to use generative AI responsibly. I.e., ethically, transparently, and in line with academic integrity.

The final mark will be calculated on the basis of all assignments. Note that BA paper will be assessed separately (i.e., your Seminar grade has no effect on your BA paper grade, and vice versa).

#### Calculation of the examination mark

- Research proposal plus anotated bibliography: 20% of final mark
- Short essay: 30% of final mark
- Presentation: 30% of final mark
- Response to presentation: 15%
- Symposium Q&A Participation: 5%

Resit: An essay based on a new research project independent of your BA paperdue in August (date TBD). The length of the essay ranges from 1500 to 5000 words and is determined by the number of successfully completed assignments. Keep in mind that your mark for the BA paper has no bearing on your mark for the Seminar. It is therefore possible to pass for the BA paper but fail the Seminar, or vice versa.
