Teaching languages

French literature, 15th-20th century, courtly love, gender, representation of women

Position of the course

This advanced course provides students with an in-depth study of French literature and culture from the 15th (novels) to the 20th century (novels and films).

Contents

Students choose one of the following modules:

Module 1(Lecturer: Alexander Roose): this module follows up on French Literature II. The literature from the Middle Ages up to the Baroque era is studied and discussed from the perspective of one central theme. We will compare the concept of courtly love (Middle Ages) with the ideals of love at the French court during the Renaissance and the libertine baroque. Attention will be devoted to the contrast between the obscene and the holy, the role of censure and the authorities, the mythological, philosophical and religious background to the changing discourse about sexuality and gender roles. We will study *Tristan et Iseut*, *Bérénice*, *Manon Lescaut*, a number of lively novella's from the 16th, 17th and 18th century as well as Constant's masterpiece *Adolphe*.

Module 2 (Lecturer: Jean Mainil): In this module, we analyse the representations of women in novels, pictures and movies, from the first "précieux" novels (Madeleine

de Scudéry) and the comedies of Molière (*Les précieuses ridicules*, 1659 en *Les femmes savantes*, 1672), to more contemporary productions. We will also analyze Flaubert's *Madame Bovary* (1857), both the text and the film adaptation by Claude Chabrol (1991). We analyse these novels, comedies and films in order to better understand the evolution in gender identity and its representation in French culture, literature and history.

Initial competences

The student may take this course if he/she has followed the courses *French literature II & French literature III* or has mastered the intended competences in another way.

Final competences

- 1 To have an insight into the literary-historical developments of French literature.
- 2 To have an insight into the evolution of the mentalities and the cultural background in France.
- 3 To be capable of writing a good essay, coherent, well structured, clearly argued and focused on the set question.
