Position of the course

This advanced course follows up on *French Literature II* and provides students with an in-depth study of French literature and culture from the 17th (theatre) and 18th century (novel, *conte*).

Exchange students may take up this course unit, for which no prior knowledge of Dutch is required.

Contents

The literature from the French Classicist and Enlightenment era is discussed from the perspective of one central theme: love and seduction, *in* literature and *by* literature. The tragic passions in the Classical theatre by Racine, the irresistible but fatal love in the sentimental novel by Prévost, the more or less explicit erotic pleasures in the works of the libertine Crébillon fils are each studied against the backdrop of the changing conceptions and discourse on love and sexuality and on their representation in different literary genres. Attention will be devoted to the reception of the discussed works in the 17th and 18th centuries, when their success was often scandalous.

Initial competences

The student may take this course if he/she has followed the courses *French literature II* & *French literature III* or has mastered the intended competences in another way.

Final competences

1 To have an insight into the literary-historical developments of French literature.

- 2 To have an insight into the evolution of the mentalities and the cultural background in France.
- 3 To be capable of writing a good essay, coherent, well structured, clearly argued and focused on the set question.
