Position of the course

This course will offer a survey of twentieth-century forms of cultural-historical research and of the concepts and methodological principles supporting such research. The central focus will be on the early modern period (16th-17th centuries). The student will become acquainted with the work of a number of important thinkers who over the past decades have come to the foreground as important sources of inspiration, as well as with the specific work-method that has become institutionalised by the work of each of them.

Contents

In this course we will thoroughly familiarize ourselves with the work of a number of prominent thinkers who in their writings have dealt with the early modern period. The most important thinkers that will be dealt with are: Jakob Burckhardt, Jules Michelet, Johan Huizinga, Aby Warburg, Norbert Elias, Michel de Certeau, Hans Blumenberg, Carlo Ginzburg, N. Zemon Davis, Stephen Greenblatt, Timothy Brook.

Initial competences

The student is familiar with the principles of cultural-historical research and has also acquired insight in the specific analysis of art works and in their historical function within a cultural context.

Final competences

- 1 to be familiar with the work of a number of prominent historians of culture
- 2 to be able to compare different visions on the early modern period
- 3 to be able to analyse and fathom a cultural-historian analysis
- 4 to be able to relate the period under scrutiny with the historical moment in which it is being studied
- 5 to be conversant with a number of crucial concepts and explanatory models
