**Teaching languages**

**Position of the course**

This course offers an introduction into Swedish literature and literary studies. It is followed by the course Swedish Literature II and Swedish Literature III (focussing on literary history).

**Contents**

This course teaches the basic terminology (in Swedish) for the analysis of literary texts and its application.

The analytical course comprehends both theoretical and practical elements. The relevant terms are first explicated and then applied to specific examples which are discussed in class.

Focus lies on narrative and drama, but poetry, childrens' literature and film adaptations might also be considered.

The students are expected to be present and to contribute actively to the classes. They will complete a number of individual tasks (in writing) by means of which they will be able to demonstrate their ability to use independently the terms and methodological tools they have been taught.

**Initial competences**

To have successfully completed the course Swedish Language proficiency I or to have acquired the necessary skills by other means.

**Final competences**

- 1 To know the basic Swedish terminology needed for the analysis of literary texts.
- 2 To be able to apply the basic Swedish terminology while reading literary texts.
- 3 To be able to participate in a discussion on literary texts in basic Swedish (B1).
- 4 To be able to report a literary analysis clearly and consistently in Swedish (B1).

**Extra information on the examination methods**

- Oral exam (40%): the oral exam evaluates the subject matter covered during the lectures.
- Written exam (40%): to the written exam, students apply the theoretical insights acquired during the lectures in the analysis of an unseen text.
- Portfolio (20%): students create a portfolio with a number of assignments that are completed during or after the tutorials. The content of the portfolio is explained in detail in the first lesson. No second exam chance for the portfolio.

**Calculation of the examination mark**

The oral exam (knowledge of and insight into the subject matter of the lectures) counts for 40% of the final score, the written exam (analysis of unseen text) counts for 40% of the final score. The portfolio counts for 20% of the final score.

**Facilities for Working Students**

1. Partial exemption from educational activities requiring student attendance
