Position of the course

In line of the course Dutch literature I and II and III, this advanced course tries to provide students with a profound survey of Dutch literary history, more particularly poetry. The survey has a chronological structure with attention to specific problems (development of different literary genres next to poetry, European influences) per century. The oversight is chronological with attention to the developments in poetry in the Netherlands and Flanders (nineteenth and twentieth century). Students are introduced to the theory of analysis and comments on literary texts (poetry).

2. The 19th century in the South
3. The 20th century in the North
4. The 20th century in the South

Initial competences

Sufficient knowledge of Dutch (oral skills and writing skills).
To have a survey of Dutch literature, from its origins until the 18th century.

Final competences

- 1 To have a general survey of the development of Dutch literature in the discussed period.

- 2 To be able to situate important authors and works within their historical context.
- 3 To have an intimate knowledge of the structural and stylistic characteristics of the poems that have been treated in the lectures.
- 4 Knowledge of poetry in the nineteenth and the twentieth century.
- 5 To be able to identify and situate names, titles, poetics and schools.
- 6 To have a clear insight into the thematic and formal relationship between the texts of the reading list and the presented survey of developments and movements.
- 7 To be able to relate one's personal reading experience to descriptions of literary history in a critical way.
- 8 Students should be able to analyze literary texts, to comment them in a literary-historical context and to present their analysis and interpretation.
- 9 Excellent practice of Dutch in written and oral form (literature report + academic group paper + oral presentation (group) + individual paper; individual paper + written and oral exam)

End-of-term examination:

1. oral exam

2. written exam

Self-directed work: continuous assessment (individual paper = with reservation: Van Bruggen)

Collective work + individual reading report (= reading list).

Students have an excellent practice of Dutch. This is part of the evaluation.

Calculation of the examination mark

50% oral exam on the lectures

50% papers + written exam; total score: /20 = individual paper: /5, reading report: /1,5,

collective work: /3,5 + written exam: /10

Students pass the examination only when they succeed for each part of the course. Students should take part in all papers (individual and collective) in order to succeed in this course.
