Position of the course

The aim of this course is to help students acquire thorough insights into the topical issues, culture and history of the German-speaking countries from a comparative and intercultural point of view; this will provide background insights for the language and literature courses in the Master in Linguistics and Literature: German.

Contents

Topical issues and topics from the culture and history of the German-speaking countries are studied in-depth from a comparative and intercultural point of view. Special attention is given to "Erinnerungsorte", a dynamic form of memory that allows for a better understanding of current debates and aspects of contemporary culture in Germany, Austria, and Switzerland in a broader sense (media, geography, political structures, social debates, etc.). Topics such as politics, religion, visual arts, music, and architecture are also covered.

In this course, heuristic and interpretive skills are practiced, as students are expected to pay attention to the representation of historical events based on source research and connect them with transformations and shifts in ideology and memory politics. We also work with unstructured data (such as social media posts) and learn to visualize them using techniques from the Digital Humanities.

Topics related to current events, culture, and history of German-speaking countries are explored comparatively and interculturally.

Initial competences

Students have successfully completed the course "History and Culture of German-Speaking Countries" (Ba2) or have achieved the desired learning outcomes in a different way.

Final competences

- 1 Students have extensive knowledge of topical issues and of the culture and history of German-speaking countries, particularly (but certainly not exclusively) the Federal Republic of Germany.
- 2 To be able to critically explain structures and topical issues from a synchronic and/or diachronic and/or comparative/intercultural perspective.
- 3 To be able to make content connections with other curriculum courses (e.g. the language and literature courses in the Master in Linguistics and Literature: German).
- 4 To be able to conduct critical research into German-speaking media and other sources of information.
- 5 To have an extensive, established and active knowledge of the German language; exceptions can be discussed, e.g. for those wishing to take this course as part of another academic programme than the Master in Linguistics and Literature: German.
- 6 Independently compare, select, use responsibly, and critically evaluate digital visualization methods to conduct analyses or present research findings. To be able to use genAl in an advanced and responsible way to write texts.

Calculation of the examination mark

Participants can acquire a surplus credit (5%) by reporting on vocational activities as part of the 'Bonusprogramm'.

Students who participate in the bonus programme, can earn an extra bonus mark. Those with a failing grade for either of the two end-of-term forms of assessment cannot pass the course as a whole. If the final score would nevertheless be a mark of 10 or more out of 20, this will be reduced to the highest unsuccessful mark (i.e. 9/20). If one does not participate in the evaluation of one or more components, one can no longer pass the course unit as a whole and the final grade, if higher than 7/20, will be reduced to the highest non-deliberable grade (i.e. 7/20). The extra bonus mark can only be awarded to students who pass the course as a whole.

Facilities for Working Students

- 1 Although attendance is highly desirable, working students may be exempted from attendance. For those classes where active participation is evaluated (e.g., tutorials), you will need to complete a substitute task that demonstrates your attainment of the intended competencies. The substitute task will be communicated to you by the instructors.
