Latin poetics and poetry, late antiquity, Ausonius, Claudian, Rutilius Namatianus, Sidonius Apollinaris, Venantius Fortunatus, itinera en travel texts, displacement, interruption, landscape, ecopoetics.

## Position of the course

This course focusses on late Latin poetics through the reading of various texts. The problem of originality of late Latin poetry will be at the center of our discussion. Is it possible to acknowledge late Latin poetry per se without using the lens provided by classical poetry?

## Contents

We read and analyze the works of Ausonius, Claudianus, Rutilius Namatianus, Ennodius, Venantius Fortunatus and other late antique authors. In doing so, we will take a thematic approach. At the same time, this course will also represents a special exercise of hermeneutics, because instead of the historicizing readings typical of our discipline, we will focus on the specific aesthetics of the time and on the function of the landscape, the environment and of other non-human aspects on the basis of eco-criticism.
