# Position of the course

Designed as a research seminar, this specialist course in Latin literature aims to provide students with an introduction to the Latin poetics of the Middle Ages (c. 500-1500). The central theme of the course is Latin in contact and dialogue with other European literatures. From the reading of a varied selection of (excerpts from) Latin poetry and prose from different periods and regions, students will gain a sharpened understanding of the literary history of Latin after antiquity and, more broadly, question the position and importance of the Latin Middle Ages in European literary history. Students are expected to participate in classes well prepared (cf. evaluation forms infra).

# Contents

The course includes the following components:

A. A theoretical introduction to the Latin poetics of the Middle Ages that starts from an interpretation and problematization of the concepts of "medieval," "Latin," and "literature.
B. A chronological literary-historical survey of Latin literature after the extinction of Latin as a mother tongue with special attention to Latin in contact with other European literary cultures.
C. An initial exploration of a specific corpus of texts related to the instructor's ongoing research.
D. The study in group and individual settings of a stated research question within the program covered using one or more self-selected texts. Considerable activity and responsibility is required of the student in view of the excerpts to be read and discussed. If desired, a portion of

the corpus may be given up as independent reading.

E. Students will be closely involved in the research activities of the instructors during the course.

#### Initial competences

To have taken the BA curriculum in Linguistics and Literature with Latin as one of the two obliged languages OR the postgraduate degree in Latin.

#### **Final competences**

- 1 to have insight in important developments in the history of medieval Latin literature, including knowledge of specific authors, genres and texts
- 2 to be able to discuss and situate seen and unseen texts within broader historical, cultural and literary contexts
- 3 to be able to compare and make connections between seen and unseen texts
- 4 to be able to apply a literary-theoretical or literary-historical research question to a given text corpus
- 5 to be able to set up, present and defend a scientific research presentation (in group)

#### **Teaching methods**

Seminar, Lecture, Practical, Independent work

#### Extra information on the teaching methods

- On campus lecture: esp. introductory and contextualising sections
- On campus response college and practicum: interactive discussions with teacher(s) and students
- Preparation for class: preparatory reading of assigned primary texts
- - Research project practicum: students conduct individual research, learn to draft a scientific argument that interacts with the lesson content, and present and defend the results before an (international) audience.

# Calculation of the examination mark

Non-period-specific:

- work ethic (10%)

- group presentation with defense (45%)

- portfolio (45%)

If one has less than 10/20 for the group presentation or portfolio, one cannot pass the entirety of the course unit. If the final score would still be a grade of ten or more out of twenty, it will be reduced to the highest non-passing grade.

(If the student did not pass the non-period evaluation, a second chance will be offered through a compensatory activity between the first and second examination periods.)
