This introductory course unit seeks to familiarise students with the history of Europe and Europe's overseas expansion in the 16th-18th centuries.

Contents

A general survey of the major political, intellectual, social, economic and religious developments in Europe. Special attention will be given to the European overseas expansion and its consequences.
