# Position of the course

This course introduces you to the history of the Japanese archipelago from the proto-historic period to the modern and conteporary times. In this process, we will also address general issues in historiography, social theory, and political philosophy. The course provides all students of Asian studies with indispensible basic knowledge about their area of choice, but is generally recommended to everyone who wants to know more about the past and present of what is today the third or fourth biggest economy of the world.

### Contents

The focus of this course is set on the history of political institutions and political economy (social organization) and covers the archaic period, the adoption, consolidation and decline of the ancient Chinese-style *ritsuryou*-order, the dawn, solidification and dissolution of the various subsequent feudal forms of social formation in the medieval and early modern periods, the rise and demise of Japan as a constitutional monarchy, and the splendor and misery of Japan as a parliamentary democracy. In focussing on structures and processes of transformation rather then the archival contingencies of sheer event history, we will have plenty of opportunities to also address questions of larger, more general concern. What are Confucianism, or Buddhism? What does "feudal" mean, and what does the word "modern" imply? What is a nation state? How do we conceptualize capitalism, fascism or democracy? And, above all: what do we actually mean, when we think or speak of the past as "history"?
