Position of the course

The development of the German language since the beginning of textual transmission, also considering the historical development of Low German (Old Saxon, Middle Low German)

Contents

After a brief introduction to the historical background, the grammar (phonology, morphlogy and syntax) of each historical stage of High and Low German is discussed, as well as the diachronic processes connecting them.

The theoretical and encyclopedic knowledge will be applied and deepened in a small individual research task.

Students reading for an educational MA degree can work on the topic "Sprachgeschichte und Schule", for which findings from German language history are used to develop educational material to help understand better e.g. difficult grammatical topics like adjective agreement. *COVID-19 / new semester arrangement:*

Also in 2022/23, the semester in the Master will be reduced from 12 to 10 weeks of teaching: • *Part of the content will be taught via recorded lessons.*

• The classes in the last two weeks of term will be replaced by those recordings. This is intended to afford the students more time to finish their essays.

Post-sessional evaluation: written exam (50%) In-sessional evaluation: independent exercises & short paper (c. 2000 words) (50%)

Calculation of the examination mark

50% post-sessional evaluation 50% in-sessional evaluation

Important:

If the student does not pass the in-sessional assessment, a second opportunity is offered through a compensatory activity between the first and second exam periods. If the student does not participate in the in-sessional OR postsessional evaluation, or has less than 10/20 for one of the evaluations, they can no longer pass the course as a whole. In case the average of the final score is equal to or higher than 10/20, the average is reduced to the highest non-passing grade (=9).
