Position of the course

This advanced course teaches students how to translate classical texts (into Dutch and English) and use the sources relevant for the study of the historical, religiousphilosophical, social and cultural developments in China. The course teaches students how to translate classical and medieval texts of different genres, and how to do research on the relationship between classical, medieval, pre-modern and modern China.

Contents

Classical texts are situated within the larger historical, religious-philosophical, social and cultural development of China. The focus is on classical and medieval texts of different genres.

Assessment moment Periodical: written examination (100%) Assessment form There is a written examination. The examination focuses on the capacity of the student to place a given source within its historical, religious-philosophical, social and cultural framework. The examination also evaluates in how far the student is able to use relevant secondary literature.

Calculation of the examination mark

There is a written examination. 80% of the examination deals with the translation, analysis, and discussion of text fragments. 20% concerns the knowledge of secondary literature.
