Position of the course

The region of the so-called "Middle East" remains of paramount importance for global politics, because of geopolitical, economic, and military-strategic interests, the threat of terror and the call of jihadism and salafism, which extends far beyond the frontiers of the region. The region is a beacon of hope (expressed, for example, in the 'Arab Spring'), as well as a place where war, persistent conflict, economic malaise, oppression of women, authoritarianism, etc. appear endemic. This course sheds light on the structures and dynamics that determine the actual politics of the region.

Contents

Through interactive classes and the reading of a variety of sources students acquire knowledge of and insight in the primary political issues of the Middle East.

Initial competences

Basic knowledge of the history of the Middle East, acquired through the course "History of the Islamic world" or self-study.

Final competences

- 1 Knowledge of the primary contemporary political questions in the Middle East
- 2 Insight in the primary actors, structures and processes that are at the core of contemporary political issues in the Middle East
- 3 Insight in the position of the region of the Middle East in global politics and of individual countries within the Middle East
