Position of the course

The basic course is part of a package of 'Domain-specific knowledge' (chronological overviews) that aims to provide a fairly complete overview of the archaeology offered by the department. In this case, the subject aims to provide a global overview of the provincial-Roman period and of the medieval and early modern periods in Europe, with a focus on NW Europe in particular.

Contents

The main aim of this course is to provide a frame of reference for our regions of the methods used, the archaeological readability and chronological development of various capita selecta for the period of the Provincial-Roman period, the Middle Ages and the early modern period.

Topics include development of military construction, settlement development (both rural and urban), burial practices, economic development, development of religious (power) centres and various aspects of material culture

Initial competences

Accessible to all students, without specific previous knowledge.

Final competences

- 1 To have a general insight into the developments in the Roman, mediaeval and early-modern periods in Western Europe.
- 2 To have a basic knowledge of a number of research topics of the archaeology of the Roman, mediaeval and early-modern periods.
- 3 To understand the evolution of the studied topics in general.
- 4 To be able to incorporate the different fields in an overview of the era in a critical way.
- 5 To be able to place the results of the archaeological study of the different fields

within its historical and methodological context.
