Position of the course

This basic course is part of a series, giving a specific chronological overview of the human past. This course intends to overview the prehistory (Palaeolithic, Mesolithic and Neolithic) of the Low Countries.

Contents

Detailed chronological overview of the prehistoric cultures and industries of the Low Countries. In addition attention will be paid to some specific research themes such as spatial analysis of stone ages sites, problems related to transitional phases (e.g. Middle to Late Palaeolithic, Mesolithic to Neolithic), the meaning of prehistoric "monuments", such as Neolithic enclosures and megaliths, etc. (topics may change from year to year).

Initial competences

- To have successfully completed the course Pre and Protohistory or to have acquired the necessary skills by other means.
- To have an insight in the general evolution of the prehistory of Europe, Western

Europe in particular.

Final competences

- 1 To have a detailed insight into the cultural evolution within the prehistory of the Low Countries (Belgium, The Netherlands and Luxemburg).
- 2 To analyse the relations between different prehistoric events critically.
- 3 To analyse various archaeological sources critically.
- 4 To analyse specialist literature published in different languages critically.
- 5 To participate actively in group discussions concerning specific topics related to the prehistory.
