Position of the course

This advanced course is part of a package Domain-specific knowledge courses, aimed at broadening the knowledge obtained during the first year. In this case the goal is gaining insight into the archaeology of the Roman world. Geographically the emphasis is on the Mediterranean region..

Contents

Functionally structured overview of the inheritance of Rome in the fields of urbanism, architecture and material culture. A series of capita selecta from modern Roman archaeology (funerary aspects, house analyses, transportation issues, urban organization, demography, the countryside ...) are presented and critically discussed.

Initial competences

- To have successfully completed the course Introduction to Greek and Roman archaeology and art or to have acquired the intended competences in another way.
- To have a broad understanding of the discipline of Classical Roman archaeology.
