Position of the course

Providing insight into the (cultural) historic sources of contemporary social and political philosophy to enable an inquiry into current social and political-philosophical theories and disputes. Knowledge about (the evolution of) philosophical theories regarding politics and society is required to understand the prevailing social and political systems, and to determine one's own position in this field.

Contents

A thorough discussion of some representative contemporary controversies, on the basis of text analysis. Examples of topics:

- the debate on (variants of) cosmopolitanism versus nationalism, within the broader context of theories on global justice

- civil rights, egalitarianism, discrimination, and civil disobedience
- digitalisation, robotisation, information capitalism, surveillance capitalism

Initial competences

- Prior knowledge of the main political-philosophical doctrines and their historical development. This course builds on some of the final compentencies of the course 'Political Philosophy' (A003401). However, having taken this course is not a prerequisite.
- Thorough knowledge of Dutch and English.

Final competences

- 1 Possessing knowledge of and insight into the major social and politicalphilosophical doctrines.
- 2 Understanding and being capable of critically discussing important social and political-philosophical controversies and disputes (past and present).
- 3 Being able to develop and argue for one's own viewpoint on relevant issues.

Extra information on the examination methods

The students are evaluated on three components:

• Preparatory assignments

Students must read the assigned text (s) and submit a preparatory assignment prior to the group tutorials. The preparatory assignments are announced in the introductory lecture and via the e-learning platform. The deadlines for submitting the preparatory assignments must be strictly respected.

• Group tutorials

After each group tutorial, the student receives a mark based on extent of participation, demonstrated understanding of the texts and quality of argumentation.

• Exam

Written open book exam

Calculation of the examination mark

- Permanent evaluation (group tutorials and preparatory assignments): 60% (12/20)
- Periodic evaluation (written exam): 40% (8/20)

To obtain a credit for this course, it is required to participate in all components of the evaluation and to score at least 50% for each component. If the average final score would nevertheless be a mark of ten or more out of twenty, this will be reduced to the highest unsuccessful mark (= 9).

Students who have not passed and want to try to obtain a credit for this course in a following academic year, have to participate in the evaluation of all three components (preparatory assignments, group tutorials, exam).
