Position of the course

This is a practical course which aims to introduce the students to basic research skills for the study of Early Modern History (ca. 1450-1750). Special attention is paid to the following: (1) Understanding the specific aims of historical research; (2) Understanding the diverse strategies through which historical literature attains these goals; (3) Understanding the role of interpretation, research questions and models in setting up historical research; (4) Mastering basic terminology of historical research; (5) Mastering efficient reading and note-taking practices in relation to historical literature; (6) Mastering efficient heuristic strategies for historical literature, and use of library collections; (7) Learning how to formulate a research question; (8) Learning how to answer a research question through historical research on primary sources; (9) Learning how to report research results in a logically structured and clearly articulated research paper.

Contents

- We focus on a specific theme in early modern history (c. 1400-1800 CE), to be announced at the beginning of the academic year. The instructor provides a basic set of research instruments.
- Each student completes a number of intermediate assignments and writes a final paper, in which the aforementioned aspects of historical research are practised.

Initial competences

- Having an elementary knowledge of historical developments
- Having a working passive knowledge of Dutch, English, French
- Having sufficient skills for writing clear and correct Dutch, English, or French (grammar, syntax, vocabulary)

Final competences

- 1 Having a basic knowledge of the diversity of sources and scientific literature for a specific historical research topic.
- 2 Being able to clearly and correctly synthesise the results of existing historical research in a *status quaestionis*.
- 3 Being able to work out a basic historical argument in a *story board*.
- 4 Being able to formulate a sufficiently limited research question concerning a

specific historical topic.

- 5 Being able to build a correct and sufficiently relevant bibliography by means of a satisfactory heuristic strategy.
- 6 Mastering the different parts of a research paper, as well as their specific functions and sub-parts.
- 7 Being able to guarantee the credibility of a research paper through footnotes and a matching bibliography.

If the student obtains a fail grade for an assignment, a resubmission can be done to obtain a pass.

No oral or written exam. Final grades are calculated on the basis of intermediate assignments, class participation, and quality of the final paper.

Calculation of the examination mark

100% permanent evaluation on the basis of:

-intermediate assignments (40%): mandatory participation to the in-class sessions

and feedback sessions

-scientifically argued research paper (60%)

Students must complete all assignments in order to pass for this course. Deadlines are strictly observed. The final paper is the most important assignment: this is why one cannot pass for this course without passing for the final paper. If a student obtains a fail grade for the final paper but an overall pass grade for the course, the latter grade is automatically reduced to 9/20.
