## Position of the course

Students will be trained in coming to grips with current issues and debates in relation to the history of the Middle Ages and in setting up and carrying out innovative research projects in those fields.

#### Contents

The topics dealt with in the research seminar change on a yearly basis. A number of great debates in medieval history will be studied and analysed by means of case studies based on actual source material. For the academic year 2024-2025 two themes are programmed, each taking up half of the course:

1) Moral and social distinction in the Early and High Middle Ages.

2) Humans and Nature in the Middle Ages

Lecturers: Sander Govaerts and Frederik Buylaert

- 5 To critically reflect on the course, resulting in a paper.
