### Position of the course

The course unit is part of the Public History practice track. Students are confronted in an in-depth way with a (annually changing) theme related to history in society outside a strictly academic context. As academically trained historians, they can play their part in various historical practices and learn to think critically about heritage and heritage policy.

### Contents

The annually changing themes are selected on the basis of topical relevance and in collaboration with actors outside academia. Experts give lectures and workshops. Students elaborate a practice in public history. They practice with media, techniques of presentation and the organisation of an event of public history. They are given the opportunity and are encouraged to make a concrete social commitment in the process. All historical periods can be dealt with.
