Position of the course

- Provide well-founded, scientific knowledge and insights about African history and the impact of this history on mentalities, global relations and contemporary African societies.
- Broaden insights in historiographic methods and scientific methodology from other disciplines that are relevant to the field of African history
- Broaden knowledge about and insight in social theories relevant to the field of African history
- Set up historical research about Africa and apply knowledge and insights regarding African history and historiography on a scientific level.
- Communicating about research methods and results with fellow student and laypersons
- Develop own critical, well-funded, scientific views on Africa within a temporal, spatial and social framework

Contents

The course provides an overview of core themes in the history of Africa, including colonialism, ethnicity and the problems of post-colonial politics.

Beyond that, its content is shaped by the interests of the students participating. Students will be expected to formulate their own prospective research topics, and to present them to the class. The teacher provides input, readings and guidance for the presentations.

Potential topics are endless; they include anything connected to the modern and contemporary history of Africa.

Initial competences

Students are familiar with historiography and have a basic understanding of non-western or world history

- 4 Students adopt a critical attitude towards their own thinking, environment and contemporary international relations on the one hand, and towards past and current issues regarding power, the economy and culture in African states and societies on the other hand.
