**Position of the course**

In the final stage of the transition program, students are required to demonstrate their mastery of a certain number of core competences of the programme: analysis of academic literature in international languages, basic knowledge of theorisation in language or literature studies, application of the basic principles of literary or linguistic analysis, written reporting in a 10,000-word academic text.

The research paper is linked to a research seminar, organised by language and/or discipline. Students writing a research paper in linguistics take the linguistics seminar. Students writing a research paper in literature choose a seminar of the language concerned or the seminar on General literary studies. Students writing a research paper on classical languages (linguistics or literature) attend the Seminar of Classical Languages.

Students are free to choose their discipline (linguistics or literature) and subject.

The programme provides students with lists of possible subjects and supervisors.

- 8 Convincingly argue why generative AI was or was not applied in the research process.
