Position of the course

This is a course at master's level and as such aims to provide an enlargement of and reflections on knowledge acquired at bachelor's level (Ghent University or elsewhere).

Contents

This course approaches ethnicity and identity formation in which language is referred to, from a post-positivist, post-essentialist and social constructivist perspective. We study ideological, sociological, and political processes of identity formation in the history and present of Africa both at the emic and metascientific levels — i.e., the role of the colonial and postcolonial sciences in these processes. Attention is paid to colonial reinterpretations of precolonial identities as well as to postcolonial and decolonial contestations of them.

Initial competences

Required to start this MA course:

- factual knowledge: basic knowledge of African geography (countries, cities, etc.), the history of the European colonization of Africa across its subregions, the history of decolonization and of post-colonial states (regimes, names of the main leaders) in Africa, etc.
- Understanding of at least these theoretical concepts: agency, assimilationism, indirect rule, emic / etic, cultural evolutionism, colonial sciences, essentialism and primordialism, language ideologies, language policy, language planning, lingua franca, interethnic language, language for wider communication (LWC), official language.

Final competences

1 The student has acquired an understanding of identity and ethnicity as a process rather than a product, of concrete cases of language-related processes of ethnicity and identity formation and reformation in the history and present of Africa, and of the central role of colonialism and postcolonial contestation therein.

2 To critically question some conventional concepts and distinctions in mainstream historiography of Africa, such as 'group', 'ethnicity', 'identity', and 'language'.
