Contemporary China, literature

Position of the course

Being able to read the literature of contemporary China (1949-present) and being able to place literature in the Chinese literary history, as well as in its economic, political and social context. Being able to deduce information concerning modern China from Chinese literature and academic publications. Being able to express oneself orally and in written form on the topics that are the subject of the discussed literature.

Exchange students may take up this course unit, for which no prior knowledge of Dutch is required.

Contents

The course is built around a selection from the literature (prose, poetry, drama) of contemporary mainland China, Taiwan, and Hong Kong. This selection is made in function of a specific topic. Appealing to the students' knowledge, academic publications, and of video fragments and interviews with the selected authors, the oeuvre of these authors is discussed and interpreted. The students learn to express themselves orally about the topics that are represented in the selected literature. The students are also trained in expressing themselves individually about the topics through oral presentations and written papers.

Initial competences

'Modern Chinese: Contemporary Chinese Literature' requires a good knowledge of Modern Chinese (level BA3) and a basic knowledge of Classical Chinese (level BA2). Further required are the knowledge of 'Oriental literatures: China', 'Method and Research: South and East Asia', 'East Asian Philosophies' and 'Society and Contemporary Issues: China'.

Final competences

- 1 Knowing the most important authors and their works, and being able to place these in the literary history;
- 2 Being able to interpret modern Chinese literature as a reflection of the political,

- economic and social developments in contemporary China;
- 3 Being able to apply the knowledge gained on the economic, political and social history of China to the contemporary Chinese literature;
 - 4 Being able to translate extracts from modern and contemporary Chinese authors to Dutch/English;
 - 5 Being able to express oneself orally concerning topics that relate to Chinese society.
 - 6 Being able to express oneself in written form concerning topics that relate to Chinese culture

Extra information on the examination methods

50 % continuous assessment:
- during the semester, the students are trained in making translations of literary works
- during the semester, the students have to give four oral presentations, and write two papers.
The students are evaluated by the teachers on the quality of their individual presentations and written papers.

50 % end-of-term assessment: written examination that consists of the translation and discussion of literary works in the genre of, or of one of the authors discussed in the classes (25 % of the total), and an examination essay (1000 words in Dutch/English) based on an oral recorded fragment about a topic that was discussed in the classes (25 % of the total).

The students have to pass for both the part continuous and end-of-term assessment. If a student does not pass for the whole of the continuous and the end-of-term assessment, there is a possibility to do a resit exam in the second examination period. This exam consists of the continuous assessment and the end-of-term assessment.

Calculation of the examination mark

50 % continuous and 50 % end-of-term assessment

Students who do not take part in the assessment of one or more parts of the course evaluation or obtain a mark of less than 10/20 for one of its parts cannot pass the course evaluation. Should the average mark be higher than 10/20, the final mark will be reduced to the highest non-pass mark (=9).
