Classical Chinese, tradition, religion and philosophy of China

Position of the course

The course discusses so-called 'traditional China', on the basis of primary and secondary sources. Each academic year some topics are particularly focused upon, with relevant research questions, and relying (also) on knowledge previously addressed in other courses. Research results are discussed in class. In addition, students analyze one topic of their choice in small teams and present their results in class.

Contents

The course focuses on pre-modern texts, discussed in a historical, religious-philosophical, social and cultural framework. Within this framework, a few topics are focused upon. The topics are analyzed on the basis of research questions and with the help of primary and secondary sources. Attention also goes to the impact of these topics on contemporary society, and to the influence on or from regions outside of China. Research results are discussed in class.

Related to the central themes, students choose a topic of their own and analyze it in small teams. The results are presented in class, and are part of the (individual) oral examination.

Initial competences

The course 'Classical Chinese: Language, text and context' requires a thorough knowledge of 'Classical Chinese' (BA 3 level), and a good knowledge of the history of China and of East Asian religions/philosophy (particularly Confucianism and Buddhism).

- 2 To be able to translate, analyze and interpret Chinese Buddhist texts.
- 3 To be able to conduct research on the basis of primary sources.

Classical/Pre-modern and Buddhist texts are interactively related to previously acquired knowledge, and are discussed on the basis of scholarly studies. Students are intensively involved, and receive guidance for the interpretation of primary sources. Some of the lessons are prepared by the students (in small groups) and presented to the class (flipped classroom).

In small groups a paper is prepared and presented in class as well as at the oral examination.

The oral examination focuses on the knowledge and contextualization of a text selection studied in class, and on the presentation made in team.

Calculation of the examination mark
