# Position of the course

This specialized course broadens the knowledge of and insight into classical literary Indian languages, by introducing Prakrit language and texts. Secondly, knowledge of and experience with Sanskrit is deepened further by reading a text from among the Jain Sanskrit classics, in the frame of academic discourses on Indian literary and cultural history.

- 2 Overview of the grammar of Prakrit (Maharashtri)
- 3 Reading and analysing a text from the Jaina repertoire. Framing of this text within the broader religious and literary context of Jainism.
- 4 Reading and analysing a text from the classical Jain repertoire in Sanskrit. Framing of this text within the broader religious, social, political and literary context.

#### Initial competences

This course requires a thorough knowledge of Sanskrit (at least intermediary level) and of the basics of the religious traditions of India (jainism and the hindu traditions).

# Final competences

- 1 Have a basic knowledge of Prakrit grammar and phonology.
- 2 Have a basic knowledge of Jaina literature.
- 3 Being able to read and explain the Sanskrit and Prakrit texts discussed in class.
- 4 Being able to sketch the historical frame of the treated texts

# Calculation of the examination mark
