Position of the course

This course is offered in the master-after-master programme in Literary Studies. Students should possess a masters diploma, preferably (but not necessarily) in literature. The course is a cooperation with Bram Lambrecht.

Contents

In this course, poetry is studied from an internationally comparative perspective. In the context of transnational literature, emphasis is placed on the production, distribution, and consumption of literature, as well as on the circulation and function of poetry in different linguistic and cultural contexts. Theoretical approaches to transnational and translational literature are applied to specific case studies, to analyse the (self)representation of poets and their work in different linguistic areas and literary systems.

Initial competences

Students should have a thorough knowledge of the literatures of at least two different languages. Students should be in possession of a masters diploma. Students should be familiar with the principles of literary research methodology.

Final competences

- 1 The student has insight into the literary context of two language areas.
- 2 The student is able to conduct a thorough analysis of literary texts and is capable of comparative literary research.
- 3 The student can apply theoretical insights from comparative studies to literary texts.
- 4 The student can communicate acquired knowledge and insights in an efficient and appropriate manner.
- 5 The student can draw critical links between conclusions from comparative literary analyses and the broader theoretical framework.

Teaching sessions combine traditional lectures with interactive discussions. Students analyse poetry from a self-chosen linguistic area, and examine the chosen texts' reception in a different language area than the language of the source text.

Theoretical texts in the field of transnational literature are read collectively and discussed critically with the lecturer.

Research questions upon which individual work will be based are discussed thoroughly in a group setting. Students prepare a presentation on a case study. Assignments are discussed during presentations, and the student submits a revised paper or powerpoint presentation at the end of the semester.
