# Position of the course

Gaining insight into major issues in modern and/or contemporary theories of art. 'Modern' refers to the period: 18th-19th century; 'contemporary' to the 20th-21th century.

# Contents

The course content frequently varies. We study topics such as the aesthetic, cognitive, and political value(s) of the arts, the relevance of beauty, the value(s) of conceptual art, aesthetic 'common sense', the universal validity claims of aesthetic judgements, etc. We confront seminal theoretical texts, manifestos and debates in modern and contemporary art theory and philosophy with current developments in the (visual) arts.

# Initial competences

Familiarity with the most important concepts and problems in philosophical aesthetics will be presupposed (e.g. as one has taken the Aesthetics I and/or II course before).

# **Final competences**

- 1 Be able to reflect and report consistently on important problems about modern and contemporary (theories of) art.
- 2 Be able to analyse modern and current problems concerning the arts.
- 3 Be able to evaluate the merits and flaws of diverse modern and contemporary theories of art.
- 4 Be able to correctly use the relevant terminology of modern and contemporary art theories in the most diverse circumstances.
- 5 Be able to adequately apply theoretical insights to concrete problems and debates about modern and contemporary art.
- 6 Be able to talk and write adequately on art-theoretical problems, such as the value(s) of art, aesthetic community, 'sensus communis', etc.
