Position of the course

This introductory course gives a historical overview of the European innovations in the theatre from 1880 until the second half of the twentieth century. The course helps students to acquire an insight into the artistic and discursive production of stage artists and to recognize its relevance for contemporary theatre-makers. Students acquire elementary skills in analyzing the available sources concerning the performing arts in Europe and develop a critical perspective on particular patriarchal, colonial, and eurocentric discourses in modern West-European theatre.

Exchange students may take up this course unit. An individual English learning trajectory is set for. Exchange students will be set an alternative exam.

Contents

This training unit offers a historical survey of the European innovations in theatre from 1880 until the second half of the twentieth century (e.g. Antoine, Wagner, Appia, Stanislavski, Brecht, ...). Special attention is given to the relation to the other arts. There is also a critical consideration of particular patriarchal, colonial and eurocentric discourses in modern West-
