Position of the course

This advanced course is a continuation of the survey courses of the 1ste Bachelor. It aims to help students to gain a more in-depth understanding of the history and theory of the visual arts of the twentieth and twenty-first centuries. Apart from a detailed analysis of carefully selected specific works, this course deals with relevant art theoretical concepts.

Contents

The course *Modern and Contemporary Art: Capita Selecta* deals with the commonly accepted post-medium condition of art today. We start with a status question of the 'pluralist' situation that marks the visual arts since the 1970s and still informs present-day developments. The course aims to develop a potential disposition to read and understand that pluriform manifestations of contemporary art, as it willy-nilly relates to the zero degree of conceptual art.

Initial competences

 - by having acquired basic knowledge of the art of the 20th and 21st centuries in another way

Final competences

- 1 To be familiar with influential key works, prominent artists and various currents and tendencies of the history of modern and contemporary art.
- 2 To be able to analyze artworks formally and thematically as well as to situate them in their social context.
- 3 To have an understanding of important artistic and cultural concepts and debates that are essential for research on modern and contemporary art.
- 4 To be able to read independently and critically important texts by modern artists and theoreticians.
