#### Position of the course

In the bachelor thesis, the student shows the ability to carry out scientific research independently. He or she gives proof of critical reflection and frames the object of research within a broader scientific and intellectual domain.

#### Contents

The content of the bachelor thesis is determined by the student, in close consultation with the staff members of the targeted study area. A supervisor oversees the progressive acquisition of a scientific habit.

A thorough heuristics and critical attitude must be linked to a theoretical framework in order to formulate an original research question in the field of the art sciences.

A written research paper contains a well-considered and well-structured elaboration and argumentation of the research subject, with proper use of footnotes and a bibliography referencing system.

Intermediate feedback sessions are organized throughout the year, individually or in group. During these sessions, the progress of the bachelor thesis is presented and discussed, and students receive interim assignments that match the specific requirements of their research work. All students present the results of their work during the last meeting.

#### Initial competences

- To be able to construct a scientific argumentation and independently formulate research questions.
- To have a critical sense.
- To be able to properly apply the rules concerning the writing of a scientific paper.

#### Final competences

- 1 To be able to do an independent and original research.
- 2 To be able to reflect critically on a research subject.
- 3 To be able to situate a research subject in a broad context.
- 4 To be able to present a scientific paper according to the scientific standards.

#### Teaching methods

#### Extra information on the teaching methods

The bachelor thesis integrates various options of work forms (OER 2013-2014). An integration seminar, organized at the end of the academic year prior to which the bachelor thesis will be effectively taken, introduces the students in the various research areas within the study program and, by extension, into the department. Afterwards the students can make a choice for a certain research domain and are divided into groups based on that. Throughout the year, feedback sessions are organized on a regular basis, individually or in group. Collective feedback sessions usually take the form of microteachings (in which students assess each other's presentations, supervised by a teacher) or tutorials. During these feedback sessions, the progress of the bachelor thesis is presented and discussed, and students receive interim assignments that meet the specific requirements of their research theme. The final form of the bachelor thesis is of course the independent work, with which the students demonstrate their independence. Feedback to teachers or tutors is not only constantly possible but also strongly recommended.
